### FINE SCHEDULE

ATTENTION: The following guidelines and fines shall be effective against all Members for any violations of the Declaration of Covenants, Conditions and Restrictions of the Foundation, the Second Amended and Restated Bylaws of the Foundation, any Policy of the Foundation and any Rules or Regulations of the Foundation.

Note1: The actual costs incurred by the Foundation in providing such maintenance shall be assessed and shall be added to and become part of the annual maintenance assessment of charge for the Private Dwelling Unit pursuant to Article VII, Section 2. The assessment of costs will continue for so long as the Foundation is providing the maintenance.

Note 2: Failure to comply with Foundation pet rules will result in a report being filed with the State Dog Warden. The offended party is entitled to file a complaint with the local District Justice, and this may result in a fine being imposed.

Repeated violations will require that the pet be permanently removed from the property. If the owner does not comply, the State Dog Warden will be contacted for removal of the pet.

Note 3: Membership rights will be suspended until quarterly or special assessments are brought current. Unpaid quarterly assessments plus penalties shall become liens against the Member's property. If legal action is taken to collect the unpaid assessments, all actual costs, including legal fees, will be passed on to the Member.

Note 4: In the event that the face amount of the check, plus the returned check fee of \$25 and any bank fees charged to the Foundation are not paid within 10 days from the date of notice, the Foundation reserves the right to prosecute for theft by deception.

Note 5: Violations of the prohibition of hunting and recreational trapping on common and private property within the Hidden Valley Community may be reported to the appropriate authorities, including the Pennsylvania State Police and the Pennsylvania State Game Commission. For the first offense, a fine will be assessed. The Foundation may, at its discretion, either issue a warning or refer the matter to the State Game Commission for prosecution. For the second and all subsequent offenses, a fine will be assessed and the matter will be referred to the State Game Commission for prosecution.

Note 6: Homeowners who fail to comply with the Paint Policy will be charged a \$500.00 administrative fee plus the actual cost of paint/stain and all materials and labor expended by the Foundation to have the unit painted.

Note 7: Use of portable fire pits or chiminea in violation of the Outdoor Fire Policy will result in fines being assessed against the homeowner. In the event of continued improper storage, placement or use of portable fire pits or chiminea in violation of the Outdoor Fire Policy, the Foundation may, at its discretion remove and impound the portable fire pit or chiminea until all fines are paid.

Note 8: Use of ATVs, UTVs, go-carts and/or snowmobiles on any roadway or common area is strictly prohibited. An operator of any ATVs, UTVs, go-carts and/or snowmobiles on any paved street, road, or parking lot owned and maintained by the Foundation will be considered trespassing. Law enforcement officers will be contacted to determine if any criminal laws were violated. ATVs, UTVs, go-carts and snowmobiles that are operated on the lots, paved streets, roads, or parking lots owned and maintained by the Foundation, or that are improperly stored, are subject to impounding.

Note 9: Unit Rental Policy 1st Offense: In the event that the 1st offense involves a criminal or an egregious act, i.e. one that creates a danger to person or property, a fine will be assessed in accordance with the fines assessed for the 2nd and 3rd offenses.
